### TOP LAMBS

Frank Shirts, Wilder, Idaho marketed the top lambs in November. Fed at Double J, the lambs returned an average of \$4.65 in grid premiums and another \$3.05 per head in

natural premiums for premium total of \$7.70 per lamb.

December's top lambs were marketed by School Bell Feeders, Kaycee, WY. With 99% of the lambs grading YG3 or better these lambs averaged \$3.73 in market grid premiums and another \$3.31 in natural premiums for a total average premium of \$7.04 per head. The lambs were fed at Double J.

Camino and Sons, Buffalo, WY started the new year off right by marketing the top January lambs. Fed at Double J, these lambs earned an average market grid premium of \$4.40 per head and another \$1.92 in natural premiums for a total premium per head of \$6.32.

MSLC pelts averaged \$6.93 in November, \$7.81 in December and \$7.54 in January.
